



We have lost out too many members out the back door in recent years. These members were good enough for us to work to attract them; they should merit us working to keep them. We must do our best to again unite them with us making a difference in our communities.

A word about Elks Training. This was a Grand Lodge Program that was discontinued. We, as a State Association, saw a need and reinstituted it as a State Program. I can tell you that there is a need. The vast majority of the questions that I get concern the statutes and Accounting and Auditing. And most of them are not very difficult – if you have opened the statute book or the Auditing and Accounting manual. Our Lodges are a business and they need to be run like one. Based upon the number of Lodges that are now being audited by the IRS, the IRS certainly knows that we are a business.
